






For the purposes of objective as mentioned in this deed the Authors of the Trust mentioned above, have constituted themselves as the Board of Trustees. The Board of Trustees shall consist of 09 persons.

b. If any deletion, Resignation, Addition, Rejection by the Board, the Alteration of Deed to be registered at all times.

8. The Board of Trustees may at any time make such arrangements to draw up such a scheme and such Byelaws and Rules at they shall in their discretion think fit for the administration of the Trust hereby constituted and the management of the property for the time being subject to the provision of the deed or any part thereof and any time amend, alter or repeal any of the said arrangement, scheme, byelaws or rules as they shall think fit. No Amendments to the Trust deed and Rules and regulations shall be made which may prove to be repugnant to the provisions of Section 2[15],11,12,12a, 12aa, 13, and 80G of the Income Tax Act, 1961,. Further no amendment shall be carried out without the prior approval of the Commissioner of Income Tax.

9. The Board of Trustees may at any time invite or without such invitation, receive any voluntary contributions from any person or persons, firm, company either Indian or nonresident Indians or from International Institutions, either by way of donation or annual or other subscription of Agency or otherwise for the subject support or for the benefit of the Trust hereby constituted and declared.

**10. DELEGATION:-**

The trustees, may from time to time, delegate to one or more of their body or any other person or committee each of their powers and duties as they deem fit, subject nevertheless, to their retaining the ultimate control and supervision.

**11. Dissolution Clause:** In case dissolution or winding up of the Trust the Assets remaining as on the date of dissolution shall under no circumstances be distributed among the members of the Committee, Governing Body, but the same should be transferred to another Charitable Trust whose objects are similar to those of this Trust and which enjoys recognition Under Section 80G of the Income Tax Act 1961 as amended from time to time.

**12. Benefits:** Under Clause 6 of I.T. Act 1961 the benefits of the Trust shall be open to all irrespective of caste, creed or Religion.

(5) Any changes with regard to the name of the Trust, its Address, Registered Aims and Objects etc., shall be promptly intimated to the Deputy Secretary, FCRA, Ministry of Home Affairs, Government of India, New Delhi, and in case of any of the above changes, fresh Registration of the Trust under these provisions of the Act should be followed.

(6) In case the Trust brings out any publications, (Registered under PRB Act.1867) and acts as correspondent, columnist, cartoonist, Editor, Owner and Publishers of such a registered newspaper at a later stage the Trust under the provisions of Section 4(1)(b) of the Foreign Contribution (Regulation) Act 1976 , the facts should be reported to the concerned Ministry immediately.

(7) The organization shall ensure before any funds are passed by/to any person/ Trust in India, the Trust under the provisions to accept Foreign Contribution under the Act i.e., (1) and shall also under the Act obtained for prior permission of the Government under Section 6 of the Act and (11) the Trust is not prohibited under Section 4 of the Act. - d. To acquire on lease, of by alienation or nature of purchase or otherwise, to construct building and other improvement for the purpose of the trust and its institutions and to manage and deal with properties, movable and immovable and all other assets of the Trust and repay loans.
